Item 5a (DR/05/16) Rivenhall Airfield – Integrated Waste Management Facility

Page 22 Background

Since publication of the report an error has been noticed. Details were submitted by the applicant with respect to Condition 15, however reference to Condition 15 is not included in the description of development as set out on page 17.

Page 28 Proposal

4th paragraph 1st sentence delete “ESS/15/14/BTE” and replace with ESS/55/14/BTE

Page 28 Proposal – list of pre-commencement conditions

delete “15 - Design details and construction materials”

Page 67 3rd paragraph 2nd sentence delete “Details have been submitted required by condition 15 with respect to the building materials for the main two-arched roof building and no adverse comments have been received.”

Insert new paragraphs (below 3rd paragraph page 67)

Details with respect to Condition 15, concerning the building materials for the main two-arched roof building, were submitted as part of the application, but due to an administrative error, reference to Condition 15 was not included in the description of development. Therefore it is not considered appropriate to discharge this condition at this time, but rather that the details be required to be resubmitted, should permission be granted.

To facilitate this, the wording of Condition 15 could be amended to allow submission of the details prior to construction of the IWMF main building, rather than prior to commencement of the development, as previously imposed. This would be in line with statutory Government policy that requires planning authorities to set out exceptional justification if ‘*pre-commencement*’ conditions are imposed on any permission. It is considered in this case, should permission be granted, the colour of materials and construction materials of the IWMF would not be prominent in the landscape, being largely below natural ground levels, and therefore a condition could be imposed requiring such details to be submitted and approved prior to construction of the IWMF (and not commencement of the development).

Delete "15" from list of conditions to be discharged

Page 76 **Recommendation**

Add point 7 as follows

7) Condition 15 to be amended to require submission and approval of design details and construction materials prior to construction of the main IWMMF building.
