#### Good afternoon.

Your query has reached the Legal Orders and Registers Team. We are responsible for responding to Notices to Acquire Land/Rights in Land Compulsorily under The Transport and Works Act 1992 as the Highway Authority.

I have completed an internal consultation of the proposal and we have the following comments and objections:

We have no concerns regarding the areas 910 and 911.

We are, however, concerned for the areas 902, 908 (in part) and 909 (in part).

I have identified that sections of both 908 and 909 on your Land Plan overlap with the Highway Boundary, this was not shown on your original Plan. I have attached a map overlay to highlight this. The areas marked orange are where your Land Plan overlaps with the Highway Boundary. You will see the 3 areas mentioned in the Notice, plus an additional, larger area that partly overlaps with 908 and 909.

It is difficult to provide meaningful comment due to the lack of detail shown within the submitted plans and in the absence of any certainty regarding what the planned works actually consist of. For example, we would have concern with regard to stopping up and the erection of a fence or similar structure in areas of highway in 902, 908 & 909 as these are likely to diminish the available visibility from the existing agricultural accesses onto the highway, which would be potentially detrimental to highway safety.

We are of course happy to discuss the plan further in order to satisfy all parties and their interests, as further discussions / clarification may result in these concerns being addressed. However, as I am sure that you will appreciate we have a responsibility to safeguard the Highway verge and visibility for vehicular access to the Highway.

Therefore, as things currently stand, we must **Object**.
