2. The development hereby permitted shall be begun before the end of 5 years from the date of the permission.

Reason

As allowed and required under Section 91 of the Town and Country Planning Act 1990, the standard 3 year period being inappropriate in this case because the works are linked to a wider redevelopment of the town centre which has a 5 year build period (permission reference: 16/AP/4458).

Permission is subject to the following Pre-Commencements Condition(s)

3. Prior to commencement of construction, a site specific geotechnical design report which confirms the depth of the top of the London Clay along with the proposed tunnel extent ground water levels within the London Clay shall be submitted to and approved in writing by the Local Planning Authority. This report must detail local groundwater flow conditions within the River Terrace Deposits at the site (i.e. flow direction and gradient) and any resulting design mitigation measures to ensure that groundwater flood risk is addressed during construction and operational phases. The development shall be carried out in accordance with the details thereby approved.

Reason:

To minimise the potential for the site to contribute to changes in groundwater conditions and any subsequent flooding in accordance with section 5.3.3 of the Southwark Strategic Flood Risk Assessment (2008).

4. If through detailed design the requirement for permeation grouting into the terrace gravels and alluvium layers becomes apparent, an Archaeological Assessment shall be submitted to and approved in writing by the Council before any work in connection with this aspect of the development is commenced. The development must be carried out in accordance with the details thereby approved.
