Please find attached the following:

1. NRF's FOIA/EIR request sent to Network Rail on 3 November 2023 (the **November 2023 Request**);
2. Network Rail's response dated 4 December 2023 to the November 2023 Request (**Network Rail's Response**); and
3. NRF's response to Network Rail's Response dated 11 December 2023 (**NRF's Response**).

We would be grateful if the attached documents could be brought to the Inspector's attention as we intend to refer to these at the procedural meeting of 18 December 2023.

During the Inquiry, we made repeated references to the various FOIA/EIR requests made to Network Rail on behalf of Bellaview Properties Limited and a chronology of those requests and accompanying correspondence is included in Adam Rhead's rebuttal evidence (see **ARR1**). The requests require the disclosure (amongst other items, e.g. Network Rail's communications with Agility/Hitachi and/or the Department for Transport) of Network Rail's optioneering studies, constructability reports and assessments of options to consider alternative sites. The attached correspondence follows on from these requests and we consider that it is important for the Inspector to have sight of the latest communications.

We have copied Network Rail's solicitors to this email.
