Carter Jonas is instructed by the United Kingdom Atomic Energy Authority (“UKAEA”) to provide advice in relation to the above-mentioned Compulsory Purchase Order and Side Roads Order, being promoted by Oxfordshire County Council. UKAEA is the owner of land at Culham Science Centre, Abingdon Road, Culham, Abingdon, registered at HM Land Registry under title number ON216210 (“the Property”). The Compulsory Purchase Order includes powers for the acquisition of part of the Property to deliver the Clifton Hampden Bypass between the A415 at Culham Science Centre and B4015 north of Clifton Hampden.

An objection was submitted by Carter Jonas on behalf of UKAEA to the proposed Compulsory Purchase Order and Side Roads Order.

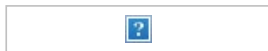
We now wish to withdraw that objection.
