  - (c) any public utility undertakers having apparatus under, in, upon, over, along or across the highways to be stopped up under the Order,

in accordance with paragraph 3, Part I of Schedule 1 to the Highways Act 1980; and

- (v) Displayed, on 24 January 2023, being a date prior to the first of the above publication dates, in a prominent position at the end of the highways to be stopped up under the Side Roads Order,

in accordance with paragraph 4, Part I of Schedule 1 to the Highways Act 1980,
